DECLARATION OF "THE KARIKILLI BIRDS SANCTUARY" AS SANCTUARY UNDER WILDLIFE (PROTECTION) ACT.

(G.O. Ms. No. 332, Environment and Forest (FRV), 23rd May 1989.)

No. II (2) [EFR] 3466/89.—In exercise of the powers conferred by section (1) of section 18 of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972), the Governor of Tamil Nadu hereby declares the areas described in the schedule below to be a Sanctuary called "The Karikilli Birds Sanctuary" for the protection of birds in the area with effect from the date of publication of the notification in the Tamil Nadu Government Gazette.

HOME DEPARTMENT

Transfer of certain areas from the Local Limits of Vyasarpaal Police Station to Sharmangar Police Station.

No. II (2) [HO] 3468/89.—In exercise of the powers conferred by clause (c) of section 2 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu hereby declares that with effect on and from the 21st June 1989, the local area specified in column (3) of the schedule below shall cease to form part of the local area of the Police Station specified in column (2) and shall form part of the local area of the Police Station specified in column (4) thereof.

THE SCHEDULE

Chengalpattu district, Chengalpattu forest division, Madurantagam taluk, No. 18, Karikilli village.

Name of the sanctuary and S.F. No.—Karikilli Birds Sanctuary, S.F. No. 188.

Area of the sanctuary—151.26 acres or 61.21 hectares and a belt of 5 kilometres width around.

BOUNDARIES

North.—Starting from western corner of S.F. No. 41 the boundary runs towards east along the southern side of S.F. Nos. 41, 40 and 20 till it meets the north-western corner of S.F. No. 19.

East.—Thence, the boundary runs towards south and east along the western and southern boundary of S.F. No. 19. Then it runs towards south along the western boundary of S.F. Nos. 16, 15, 12 and 14 till it meets the southern boundary of S.F. No. 14.

South.—Thence, the boundary runs towards south-west and then north-west along the northern boundary of S.F. No. 189 till it meets the eastern boundary of S.F. No. 187.

West.—Thence, the boundary runs towards north along the eastern boundary of S.F. Nos. 182, 120, 117, 101, 100, 99 and 76 till it meets the north eastern corner of S.F. No. 75. Thence, the boundary runs towards west along the northern boundary of S.F. Nos. 75, 70, 65, 64 and 63 and then towards north-west along the northern boundary of S.F. No. 45. Thence, the boundary runs towards north till it meets the starting point.
