

APPENDIX

NOTIFICATION

Whereas the Government of Tamil Nadu considers that the Koonthangulam Tank in Koonthankulam village and Kadangulam Tank in Kadangulam village in Nanguneri taluk in Tirunelveli Kattabomman district, described in the Schedule below is of adequate ecological, faunal, floral, geomorphological, natural and zoological significance, for the purpose of protecting, propagating, developing wild life and its environment.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 18 of the Wild Life (Protection) Act, 1972 (Central Act 53 of 1972), the Governor of Tamil Nadu hereby declares his intention to constitute the said area as Koonthangulam-Kadangulam Birds Sanctuary.

5. BOUNDARIES --

(i) Survey Numbers 62 and 64 of Koonthangulam village:

North.— Northern boundary runs along the southern and eastern side of the S.F.No.63, southern side of S.F.Nos.26 and 27 of 42, Koonthankulam village.

East.— Eastern boundary runs along the western side of S.F.Nos.61,65,66,69,70,71,72,73 and 146 of 42, Koonthangulam village.

South.— The southern boundary runs along the northern side of the S.F.Nos.147 and 161 of 42, Koonthangulam village.

West.— Western boundary runs along the eastern side of S.F.No.324, southern side of S.F.No.328, southern and eastern sides of S.F.No.273, eastern side of S.F.Nos.272,271,270,269,268,267,266,262 and 263 of 42, Koonthangulam village.

(ii) Survey Number 157 of Koonthangulam village and S.F.No.254 of Kadangulam village:

North.— Northern boundary runs along the southern side of S.F.Nos.156, 155, 154, 153, 139, 138, 137, 136, 134, 133, 132, 131, 130 of 42, Koonthangulam village.

Southern side of S.F.No.40, southern and eastern side of S.F.No.41 of 42, Koonthangulam village.

Southern side of S.F.Nos.300, 299, 298 and 290 of 41, Kadangulam village.


East.— Eastern boundary runs along the western side of S.F.Nos.289 A, 288, 287, 286, 285, 284, 271 and 267 of 41, Kadangulam village.

South.— Southern boundary runs along the northern side of S.F.Nos.260, 259, 258, 255, 250, 251, 252, 253 of 41, Kadangulam village.

West.— The western boundary runs along the southern and eastern sides of S.F.No.158, eastern side 166 and 161 of 42, Koonthangulam village.
