ORDER:-

The Hon'ble Chief Minister of Tamil Nadu has made the following announcement under Rule 110 on the floor of Tamil Nadu Legislative Assembly on 11.8.2014 :-

“இடம் பெயர்ந்து வரும் பல்வேறு பறவையினங்களின் குளிர்கால புகலிடமாக மட்டுமின்றி, உயிர்ப் பன்மை செறிந்ததாகவும் விளங்கும் விழுப்புரம் மாவட்டத்திலுள்ள ஓசூடு ஏரிப் பகுதி தமிழ்நாட்டில் 15 வது பறவைகள் சரணாலயமாக ஆக்கப்படும்.”

2. Based on the above announcement, the Principal Chief Conservator of Forests and Chief Wild Life Warden has sent a draft notification proposal for declaration of an extent of 331.78.5 Hectares in Putturai and Perambai villages in Vanur Taluk, Villupuram District as “Oussudu Lake Birds Sanctuary” under sub section (1) of section 18 of the Wild Life (Protection) Act, 1972 (Central Act 53 of 1972).

3. The Government, after careful examination, accept the proposal of the Principal Chief Conservator of Forests and Chief Wild Life Warden for declaration of the area to an extent of 331.78.5 hectares of Lake in Resurvey No.106 of Putturai village and Resurvey No.1/1 of Perambai village of Vanur Taluk, Villupuram District as “Oussudu Lake Birds Sanctuary” under sub – section (1) of section 18 of the Wild Life (Protection) Act, 1972 (Central Act 53 of 1972). Accordingly, the Notification appended to this order will be published both in English and Tamil in Tamil Nadu Government Gazette and in Tamil in the District Gazette of the Villupuram District.

4. The Tamil Development and Information Department is requested to send immediately a Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai for publication in the Tamil Nadu Government Gazette and in the District Gazette of Villupuram District.

NOTIFICATION.

Whereas the Government of Tamil Nadu considers that the area of Oussudu Lake in Putturai and Perambai villages in Vanur taluk in Villupuram district described in the Schedule below is of adequate ecological, faunal, floral and geomorphological significance for the purpose of protecting, propagating and developing wildlife and its environment.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 18 of the Wild Life (Protection) Act, 1972 (Central Act 53 of 1972), the Governor of Tamil Nadu hereby declares his intention to constitute the said area as Oussudu Lake Birds Sanctuary.

BOUNDARY DESCRIPTION.

North.- 74, Putturai village resurvey numbers 104,27,26 and 15 from East to West.

South.- 73, Perambai village resurvey number 52, Puducherry – Vazhudhavur road.

West.- Puducherry Union Territory boundary.

East.- 73, Perambai village resurvey number 2 and 74, Putturai village resurvey numbers 342,341,337,330, 329,328, 106/15, 327 and 336 proceeds northwards, further towards westwards in resurvey numbers 108 and 107, turns eastwards and proceeds northwards in resurvey numbers 109,112,113,119,106/7,14,15,12 and 128, then turns westwards in resurvey numbers 129 and 131; and turn northwards in resurvey numbers 131,132,133,101, 103,106/5,102,90,106/4, 3 and 88. Further, starts from resurvey number 7 of 73, Perambai village southwards and proceeds in resurvey numbers 6, 5 and 4 northwards.
